Municipality of Greenstone Landfill Environmental Assessment

As part of the planning process for the Municipality of Greenstone Landfill Environmental Assessment, a terms of reference was submitted to the Ministry of the Environment for review as required under the *Environmental Assessment Act*. If approved, the terms of reference will serve as a framework for the preparation and review for the environmental assessment for the proposed undertaking.

The Corporation of the Municipality of Greenstone has initiated this study to review alternative options for municipal solid waste management within the Municipality. The need for the study is as a result of the closure of several rural MNR owned landfill sites and the limited remaining lifespan of the existing Geraldton Ward landfill site.
