



## POPLAR LODGE PARK SEASONAL LOTTERY SYSTEM

### CONDITIONS OF APPLICATION AND SITE SELECTION

#### ELIGIBILITY AND APPLICATION

Only one application per family is permitted. Family is generally defined as parent(s) and children under 18 years of age.

**NOTE: Submitting multiple applications under different names, applying on behalf of someone else, or completing an application for site occupants other than themselves will result in forfeiture of the site and seasonal camping fees as well as disqualification from the next season's draw.**

Approximately 50% of our electrical sites will be awarded (23 sites) and 15% of our non-electrical sites will be awarded (3 sites) during the seasonal draw.

Electrical Sites – Seasonal -  $\$1,854.68 + \$241.11$  (HST) =  $\$2,095.78$ .

Sites: 1, 4, 6, 8, 13, 20, 21, 22, 23, 24, 26, 27, 30, 54, 55, 56, 58, 60, 61, 62, 67, 68, and 69.

Non-Electrical Sites – Seasonal -  $\$1,550.45 + \$201.56$  (HST) =  $\$1,752.00$ .

Sites: 40, 41, and 42.

By submitting an application for the seasonal site lottery, applicants are not guaranteed a Seasonal Site at Poplar Lodge Park (PLP). The order of the draw will determine site selection. Successful draw applicants are required to provide payment in full for the chosen site within a 24-hour period from when they are contacted by a municipal employee.

A non-refundable deposit payment of \$100.00 via credit card to the Municipality of Greenstone must accompany an application by the required deadline. Applications without the required payment or paperwork will not be accepted.

It is your responsibility to ensure that your payment reaches us before the deadline date to ensure your application is included in the draw.

All applications must be submitted electronically to [denise.cote@greenstone.ca](mailto:denise.cote@greenstone.ca), by mail, or in person at the Beardmore Ward Office. A link to the application will be provided.

All applications must be submitted no later than 3:00 p.m. EST on Thursday, May 1, 2025.





## **DRAW PROCESS**

The 2025 draw for seasonal campsites at Poplar Lodge Park will be held at the Beardmore Ward Office. Calls will begin immediately after the draw and all successful applicants will be notified by phone BY Monday May 5, 2025.

The draw will be performed by a municipal employee and witnessed by two (2) additional municipal employees. NO applicants will be in attendance. The first name drawn will have first choice of the available Seasonal Sites and so on.

Successful applicants will be notified by phone by Monday, May 5, 2025, in the order of which their name was drawn to choose their Seasonal Campsite. Please have your campsite preferences ready when notified by the municipal staff of your success in the draw. This will help us avoid delays when choosing a site.

For those who are unsuccessful in the draw (did not have their name drawn) and are interested in a monthly site, a separate draw will be held immediately following the seasonal draw. Monthly sites will begin on the opening day and run for 31 days. The site must be paid in full prior to occupying your site.

There is NO guarantee that you will be successful in the monthly draw if we have more people than sites.

Monthly (calendar month)

Electrical Sites  $\$727.32 + \$94.55$  (HST) =  $\$821.87$ .

Non-Electrical Sites  $\$607.94 + \$79.03$  (HST) =  $\$686.97$ .

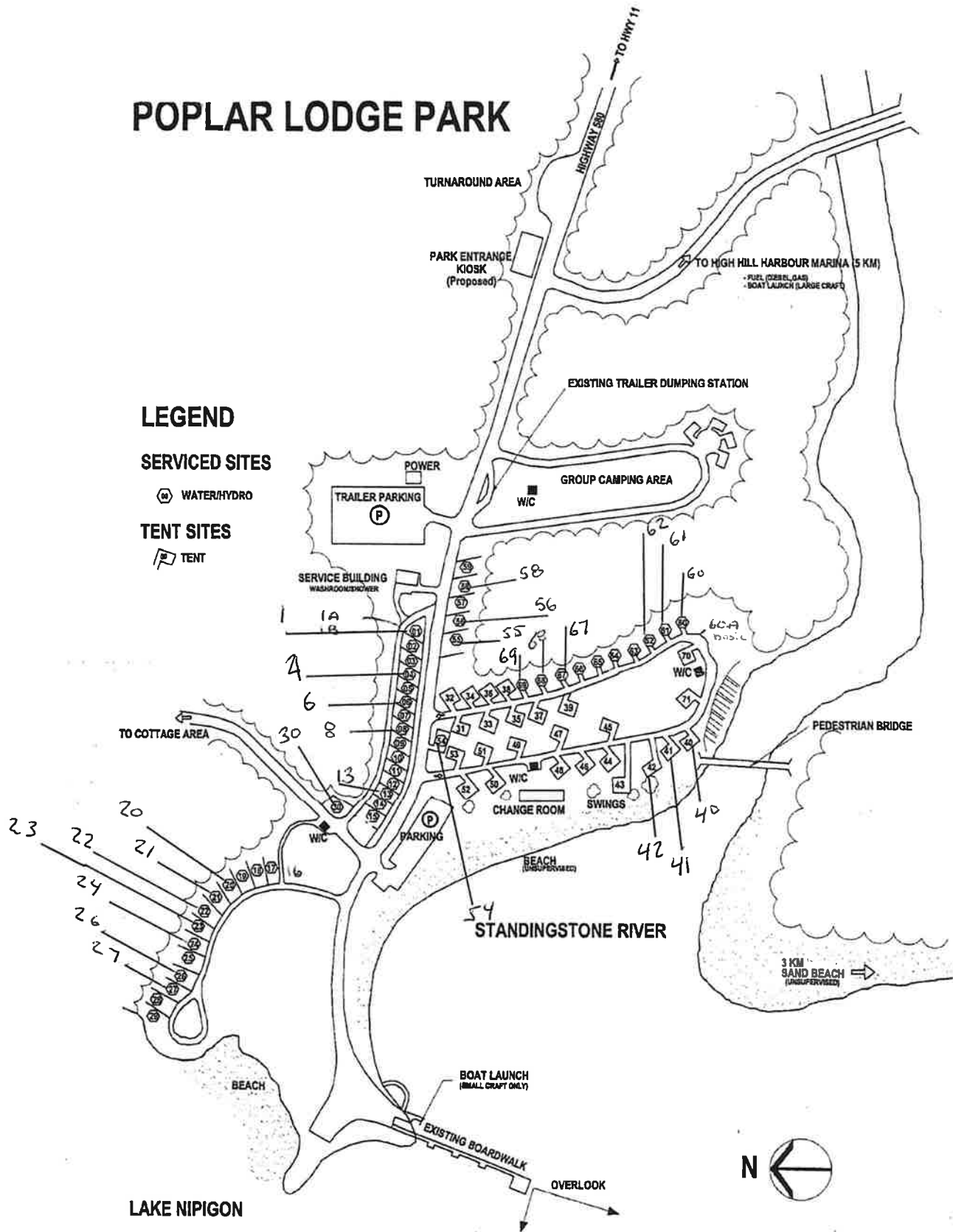
